IRISH PENAL REFORM TRUST: RESEARCH AND POLICY OFFICER (MATERNITY LEAVE)

Applications are invited for the post of Research and Policy Officer (Maternity Leave) with the Irish Penal Reform Trust (IPRT). The successful candidate will be responsible for developing the policy base for IPRT's campaigning work, including carrying out research and engaging with key stakeholders in the Irish penal system.

The Irish Penal Reform Trust Ltd (IPRT) is Ireland's leading non-governmental organisation campaigning for respect for rights in the penal system with prison as a last resort. IPRT is committed to progressive reform of the penal system based on evidence-led policies. IPRT will achieve these goals through:

- Conducting and disseminating high quality research and policy work
- Raising awareness of our work and of penal reform issues more generally
- Campaigning and building alliances through constructive engagement with all key stakeholders in the penal system

IPRT is a small organisation with four full-time posts: an Executive Director who reports to a voluntary Board of Directors; a Campaigns and Communications Officer; a Research and Policy Officer; and an Office Manager.

The United Nations High Commissioner for Refugees Office in Ireland is seeking a motivated and flexible team player to fill the following vacancy: Associate Protection Officer (NOB/P2 equivalent)

Under the supervision of the Head of Office and in close co-operation with other members of the team, the incumbent will perform the following duties:

- Promote international law and standards relevant to the protection of refugees, asylum seekers and stateless persons and foster their consistent interpretation and application
- Advise on developments in national jurisprudence and legislation
- Facilitate the participation of persons of concern in the work of the Office
- Design and deliver training, advice and other supports to the national authorities and key stakeholders
- Oversee and manage individual cases including those relating to SGBV and child protection
- Promote and contribute to measures to identify, prevent and reduce statelessness
- Maintain and develop networks with key partners in Ireland and with protection colleagues under the UNHCR Regional Representation for Western Europe
- Stay abreast of relevant political, social, economic and cultural developments

VLM: RESEARCH INTERNSHIP – DUBLIN AND ETHIOPIA

VLM seeks a research intern to join their team this summer for a three month internship in Dublin with travel to Ethiopia. VLM is offering this unique opportunity to a motivated individual who is willing to design and carry out a piece of research focused on measuring and evaluating the outcomes of VLM's work overseas and at home.

The ideal candidate should be a graduate (NFQ Level 8/Honours Bachelor degree) in the field of development, social science or a related discipline, with experience in research and report writing from employment or education. Previous experience of living or working in a developing country is desirable.

The internship will start in early June and conclude at the end of August, during which time the intern will travel to Ethiopia to meet with VLM's partners and visit projects supported by VLM as part of the research. All costs of this trip are covered and the intern will receive expenses to the value of €600 upon submission of the final report.

Since its establishment eleven years ago by the Irish Vincentian Fathers, VLM has aimed to support the building of a future for those in the most disadvantaged communities in Ethiopia. VLM is primarily a volunteer sending organisation, placing ten to fifteen volunteers in various projects across Ethiopia every year, also supporting the development of a range of projects directly through fundraising.

The overall aim of the research is to establish a comprehensive picture of the outcomes of VLM's work in both Ethiopia and Ireland over the past eleven years.
